AFHE provides a goody bag stuffing service where we assemble 1,800 bags for our attendees. If you wish to participate in the goody bags, you would pay the fee and provide 1,800 copies of your item (we do not make copies). If you have multiple items, for example a catalog and a flier, you would pay \$65 times the number of items and you would provide 1,800 copies of each item. If you had two items (i.e. a catalog and a flier), you would pay \$130 and supply 1,800 copies of each.

**ALL GOODY BAG ITEMS MUST BE REVIEWED PRIOR TO ACCEPTANCE.** Please submit one **sample of each item** you would like to have inserted along with your **Exhibitor Application** and fee payment. Upon review and acceptance, a confirmation will be sent to you with instructions and deadline for sending your items.

## AIRPORT INFORMATION

Sky Harbor International Airport is located in Phoenix between 24<sup>th</sup> Street and 44<sup>th</sup> Street (west to east), between Washington and University (north to south), and about four miles due east of the convention facility. For those without a vehicle, the Valley Metro Light Rail offers daily service from the airport to the Phoenix Convention Center and the Hyatt Regency from 4:00 a.m. to 11:00 p.m. At the airport, proceed to Ground Transportation and board the PHX Airport Shuttle to Metro Light Rail Line. Next, board the Metro Light Rail toward Montebello. De-board at the Central/Washington Station. The Phoenix Convention Center is one block to the southwest. The Hyatt Regency is one block to the east. The cost is \$1.75 per person.

## HOTEL INFORMATION

The Hyatt Regency has offered special rates for our group. When making reservations, be sure to mention you are with Arizona Families for Home Education (AFHE). NOTE: Rooms are limited and reservations are on a first-come, first-served basis. The Hyatt Regency is located just a couple of blocks from the South Building of the Phoenix Convention Center. Breakfast is **not** included. There are additional hotels in the downtown area if you prefer. However, we have not made group discount arrangements with any other hotels.

# **AFHE EXHIBITOR GUIDELINES**

## **PARTICIPATION**

Businesses that sell products or services designed to meet the needs of homeschooling families are invited to apply for exhibit space during Arizona's 27<sup>th</sup> Annual State Homeschool Convention and Curriculum Fair. No virtual/online schools or charter schools will be accepted as exhibitors. Participation in this event is by invitation only. AFHE reserves the right to refuse any application without further explanation.

## **USED BOOK DISTRIBUTORS**

Companies whose inventory is primarily used books and/or curricula are not eligible to apply for this curriculum fair. We are not hosting a used curriculum sale and wish to have new books and curriculum available for purchase by our attendees.

## **COMPANIES WITH MULTIPLE DISTRIBUTORS**

i.e. Usborne Books, DK Family Library, NEST Entertainment, etc.

We limit representation in the Exhibit Hall. When filling out your application, please list the publishers of which your inventory primarily consists.

## **NUMBER OF BOOTH REPRESENTATIVES**

Your company may have up to three (3) adult booth representatives per each 10'x10' booth space you rent. Any additional representatives must pay the regular attendee admission price of \$60.

## **CHILDREN**

Children of booth representatives must remain with their parents at all times.

## **EXHIBITOR CUSTOMERS**

Please be aware and advise your customers that they must pay the convention admission fee in order to enter the Exhibit Hall.

## **SUBLETTING OR SHARING OF BOOTH SPACE PROHIBITED**

Exhibitors may not sublet their booth space to other companies or businesses.

## **DISTRIBUTION OF FLIERS PROHIBITED**

Exhibitors may only distribute fliers, brochures, business cards, catalogs, etc. from within the boundaries of their booth space. It is prohibited for exhibitors to have a representative walking around distributing printed materials or advertising their business to convention attendees. No printed materials from exhibitors may be placed in any public area (including walls, restrooms, tables, etc.).

## **PROMOTION OF PUBLIC OR PRIVATE SCHOOL PROGRAMS PROHIBITED**

Exhibitors may not promote public-school-at-home programs or other publicly funded programs for homeschoolers. Exhibitors may not promote programs for homeschoolers through private schools at the AFHE convention.
